**1. Purpose:**

This policy document outlines the guiding principles and procedures for the admission of students to Rai University.

**2. Scope:**

This policy unequivocally covers admission standards, procedures, and processes for applicants from national and international backgrounds for all the programs offered by Rai University.

**3. Objective:**

- The objective is to choose students from a broad pool of candidates through a fair and equitable selection process.
- Additionally, the university is dedicated to identifying students from diverse backgrounds who are eager to excel in engaging programs and support their development as valuable contributors to society.
- The university will promote its programs at national and international levels to reach all potential beneficiaries.
- The University is committed to providing all students with equal educational opportunities and does not discriminate based on gender, marital status, family status, religion, age, disability, race, or socio-economic background. However, in certain cases, quotas may be allocated to promote the inclusion of underrepresented groups.
- The academic council decides the minimum eligibility criteria for all the programs based on the recommendations made by the respective Board of Studies.
- The university will offer admission to students based on academic and other eligibility criteria. This will be further reviewed to determine if appropriate accommodations can be made for first-generation graduates and underrepresented groups, including minorities, low-income students, lateral entrants, women, refugees, and students with disabilities. In special cases involving extenuating circumstances and other contextual factors, including ongoing hardships, the university may provide reasonable relaxation in the thresholds.
- The university may offer discounts or exemptions on fees for tuition, mess, and accommodation for students from underrepresented groups, based on recommendations from the Academic Council and verification of background information.

- The University offers merit scholarships for students based on their performance in the last examination and interview conducted by the university.
- Special preference in admissions and/or waiver/scholarship may be given to women and transgender applicants, taking into consideration their potential extenuating circumstances and contextual factors.

4. **Responsibilities:**

- The university's admission cell is dedicated to ensuring that admission policies and procedures are implemented fairly, consistently, and in alignment with the university's objectives, while also adhering to relevant legislation.
- The academic council establishes the eligibility criteria for all courses offered by the university.
- The fee fixation committee determines the fee structure for the various programs.
- Additionally, the admission and outreach team oversee activities like Open Days, school visits etc. to distribute both hard copy and digital promotional materials for the university's programs and opportunities.

5. **Legislation:**

- Admission requirements are governed by UGC, Gujrat government and university legislation, standards, as well as university policies and procedures.
