ANTI RAGGING COMMITTEE

Re-Constitution of the Anti-Ragging Committee as per UGC "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009".

As per the order of the Hon'ble Supreme Court of India, the Ministry of Education (formerly Ministry of HRD), Govt. of India constituted a Committee under Dr. R.K. Raghvan to give suggestions on the means of prevention of ragging in educational institutions. The Raghvan Committee submitted its report to the Supreme Court on the menace of ragging and measures to curb it. Further, the Supreme Court has directed various authorities of the government-including UGC, to implement the recommendation of the Raghvan Committee. Accordingly, UGC vide its letter No.: F 1-16.2007 (CPP-II) April 2009 i.e. UGC "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" to prohibit, prevent and eliminate the scourge of ragging including any derogatory conduct by any student or students.

The Rai University, Ahmedabad has re-constituted this statutory committee in adherence to the above regulation. The following officials are appointed as Anti Ragging Committee members with immediate effect till further office order:
